

Insurance & Risk Management

Does the stock market interest you? Would you like to be able to run your own business and keep the books? Or would you like to consult people on their finances? If you answered “yes” to these questions then maybe a career in financial management is for you.

An insurance manager is trained to apply his/her analytical skills to the problems facing financial institutions and individual investors while developing an understanding of today’s financial markets. This major can lead to a career in Business Financial Management, Banking, and many others.

Insurance and Risk Management majors take courses from one of two concentrations geared towards their future careers objectives.

Skills and Competencies

The finance and risk management major provides students with basic competency in the functional areas of finance and risk management. The program provides students with an educational foundation that is needed to prepare for professional exams and national licenses in financial analysis, insurance, banking, risk management and other financial areas. This major combines the applications of analytical skills to the problems facing financial managers, financial institutions, individual investors while developing an understanding of the risks and rewards of the world’s financial markets. This program leads to careers in business, deposit and commercial banking, investment banking, securities markets, insurance, risk management, financial planning and entrepreneurship.

Job Outlook

Median annual earnings of insurance managers were \$125,080 in 2017. Employment of insurance managers is expected to grow 19% between 2016 and 2026, much faster than the average for all other occupations. Several core functions such as risk and cash management are expected to be in high demand over the next decade.
