HOW TO APPLY

International student applicants, including those from Canada, must provide additional credentials to satisfy U.S. immigration regulations. To apply for admission to NMU, submit the completed application with signature and follow all instructions below.

APPLY. You may apply online at nmu.edu/apply or by completing and mailing this form.

SUBMIT \$35 APPLICATION FEE. Mail a check or money order or pay by credit card by calling 1-906-227-2650, or online: nmu.edu/appfee.

REQUEST ACADEMIC RECORDS/TRANSCRIPTS. Request official, original transcripts of ALL secondary school work (U.S. and non-U.S.), official certificates showing results of any standardized examinations taken in your home country ("O" levels, "A" levels, etc.), and official transcripts of any colleges, universities or trade schools you have attended be sent directly from the issuing institution to Northern Michigan University. Certified translations are required for any documents not originally in English. These translations must be complete, word-for-word, and in the same format as the original document. Students have the option of using WES ICAP or ECE for non-U.S./non-Canadian educational documents (see below).

SUBMIT EDUCATION CREDENTIAL EVALUATION. Submit all non-U.S., non-Canadian* academic records to a credential evaluation agency along with their fee. A "Course-by-Course" report--or equivalent--must be selected. NMU uses the information on the report to help determine admissibility and any transfer of credit. (NMU will notify you if a subject analysis report is needed to determine transfer credit.) Options include Education Credential Evaluators (ECE), North American Educational Group (NAEG) or World Education Service (WES). ECE and the WES ICAP service allow applicants to submit their official educational documents only once to the agency. NMU would then receive the verified

documents from the agency along with the evaluation report.

If, at the time of application to NMU, you have course work in progress at a non-U.S./non-Canadian* institution, you must also submit your additional documents for evaluation upon completion of your current study. There will be an additional fee to the agency for this and upon receipt of the final report, NMU will review your admission status again to ensure that you meet admissions requirements.

*An evaluation of credits may be requested for some Canadian institutions' documents. Evaluations may be waived for some international schools affiliated or aligned with U.S. institutions. NMU will notify applicants regarding any requests or waivers.

PROVE ENGLISH PROFICIENCY. Non-native speakers of English must prove an adequate level of English language proficiency for admission into an academic program. (NMU also offers an ESL program.) English language proficiency for admission can be demonstrated in one of the following ways:

» English proficiency tests: TOEFL (minimum score of 61 iBT/173 CBT/500 PBT); IELTS (minimum overall band score of 6.0); MELAB (minimum score of 69); PTE Academic (minimum score of 50); or ITEP (minimum score of 3.7).

» Diploma from a U.S. high school (other proof may be required if courses on transcript are listed as ESL).

» Diploma from an international school with U.S. regional accreditation (as verified by AdvancED at advanc-ed.org).

» Diploma from IB curriculum school where medium of instruction is English in applicant's program (as verified by IBO World Schools at ibo.org).

» Diploma from secondary education in a country where English is the official language. Transcript must show four years of high school English (composition and literature-based) with C or better grades. List includes: Antigua & Barbuda, Australia, Bahamas, Barbados, Belize, Canada (except Quebec), Dominica,

Fiji, The Gambia, Ghana, Grenada, Guyana, Ireland, Jamaica, Kenya, Kiribati, Liberia, Micronesia, Namibia, Nigeria, Seychelles, Sierra Leone, Solomon Islands, St. Lucia, St. Vincent Grenadines, St. Kitts & Nevis, Trinidad & Tobago, United Kingdom, Uganda, Zambia, Zimbabwe.

» Scores of 28 or higher on the SAT Writing and Language section AND a score of 560 or higher on the Evidence-Based Reading and Writing Section.

» Cumulative GPA of 2.0 or higher in 12 or more college-level credit hours from a U.S. institution of higher education. Credits must include college-level English composition and/or speech with grades of C or higher.

» Successful completion of Level 112 in the ELS Language School.

» Other proof of English proficiency may be considered on an individual basis.

PROVIDE CERTIFICATION OF FINANCES.

Applicants must provide documentation that they have the ability to finance their education at Northern Michigan University. This is accomplished by completing the certification of finances section of the international student application for admission and providing either the bank official's signature on that section or a separate letter from the bank official or a bank account statement. If someone other than you is financing your education, the sponsor must sign the application ("guarantor") or provide a letter stating his or her intention to provide financial support. Admission to Northern Michigan University requires completion of the steps above and meeting the requirements as specified under the applicable applicant status (freshman, transfer, etc). Once a student is admitted, NMU will issue an I-20 AB form to the student.

NMU HOUSING POLICY. All single undergraduate students are required to live in the residence halls while enrolled for classes at Northern, except students who: a) have reached junior status (56 or more hours of college credit) prior to registration for classes, or b) have resided four (4) or more semesters in residence halls, or c) are twenty-one (21) years of age or older on or before the last official day of registration, or d) are residing with their parents or legal guardians within commuting distance. This housing requirement is a condition of enrollment that must be met throughout the academic year. Northern’s housing contract provides a variety of meal options. Exceptions to the housing requirement must be requested in writing to the Housing and Residence Life Office, 1401 Presque Isle Avenue, Marquette, Michigan, USA 49855-5301. This does not constitute an application for housing. Information will be sent to you after you are admitted to NMU.

HEALTH INSURANCE. All international students and their dependents (excluding Canadians) must enroll in a health insurance plan designated for them by NMU which will provide full and continuous coverage through a U.S. based insurance company. The charge for this insurance will be added to the student’s tuition billing each semester.

ORIENTATION. All new international undergraduate students are required to participate in orientation. For international students, the sessions that seem to work best are the ones held 6 days prior to the start of the fall and winter semesters. You will receive information about orientation once you are admitted to NMU.
