- a. Superior Edge
 - *Mackenzie Meyer (President of Superior Edge)*: We are asking for \$15,262.50 to bring Abigail Heringer, a former contestant on The Bachelor. She was the first deaf contestant and she brings a lot of awareness to that community through her platform. We are hoping to bring her to talk about her story.
 - SFC Deliberation:
 - **a.** *Emily*: They did tell me that they were potentially going to ask for an increase, but I told them to stick with this budget and we could adjust this one to make sure they get approved in time.
 - **b.** *Eli*: This \$15,000 is a substantial amount of money, so that is about 30% of our available funds as of right now.
 - *Emily*: I will say, I was sent a financial sheet this morning that claimed we have much more money than I said earlier. I am going to meet with Kelly to discuss the number and figure out actually how much we have, but just so you guys know, there may be more money than we think available.

 - Freddie Sims (Founder and President of Social Justice for Us): Social Justice for Us started as a local non-profit, and then we affiliated with Northern this past year. I have been living in Marquette for 11 years and have never seen someone who looks like me on local TV, on a billboard, or represented in general. So we wanted to shed light on marginalized groups that don't normally get that spotlight. We held a photoshoot called Power In Unity, in which we photographed members of these groups and had them give words that meant a lot to them and explain why. It allows others to see members of these groups, allows them to meet others like themselves, and also to see themselves in a spotlight they aren't normally given. We did secure a Student Art Gallery slot to display all of the photos on the Friday of the last week of February as well. We are asking for \$850 to cover the frame costs, a background replacement for the photographer, studio fees, and a few other things.
 - Sydney: That last week is actually spring break, so maybe you could do it on a different day! Perhaps even a Thursday or an entire week rather than one Friday.
