## SEXUAL MISCONDUCT POLICY – DRAFT

Mr. McCamman and Ms. Koski provided a summary of the MASU call regarding interim sexual misconduct policy drafts/revisions at the public universities in Michigan based on the unofficial Department of Education proposed guidelines, 60-day comment period, and the differences between the DOE guidelines and the 6<sup>th</sup> Circuit Court of Appeals in Baum, etc.

The Committee reviewed a draft of NMU's Sexual Misconduct Policy changes. Discussion was held regarding the importance of keeping policy separate from the procedures, which is the process for all NMU polices. A correction will be made to the website to ensure this policy follows the same format. Policies are approved by the Board and procedures approved by the President.

Interim vs. Final Policy – NMU will continue to review and make revisions to the policy at this time, keeping the interim policy fluid until the DOE guidelines and Doe vs. Baum have been finalized.

The campus community will need to be educated to ensure everyone is aware of the changes.

### **OVERVIEW**

- Need to keep the policies separate from the procedures for this policy. This correction will be made to the Sexual Misconduct Policy on the website.
- Policy will be reviewed/revised and kept fluid (this is an *interim* policy) until the DOE guidelines have been finalized

## **NEXT STEPS**

- The university committee will continue to review the interim policy and procedures and send a draft to this Committee for their review. At that time, the Committee will determine if a recommendation should be made to the full Board to approve the revised policy. This will be done at the December 2018 or February 2019 meeting.
- A tentative meeting of the Ad hoc Policy Review Committee will be scheduled for Wednesday, December 5, 2018 at 10:00 a.m. to review the draft from the university committee if they have had the appropriate time to review and update the draft. The Ad hoc Policy Review Committee should receive the draft 24 – 48 hours prior to the meeting date.
