 association (alumni Rachel McCaffrey, Lani Gahiji, Jamie Glenn as well as Robyn
 Stille-Executive Director of Alumni Relations, and Lindsay Demske-Alumni
 Association rep.) discussed Alumni Awards, working on jobs/internships, speakers
- Latino Student Union (LSU) had approx. 20 students attend first meeting of the semester (approx. 5 students attended in the past two years). Participating in the statewide Latino graduation celebration in Lansing has helped re-energize the group. After their first meeting, LSU approached Cruz to host a Baile (dance) with live music from Latin America. Cruz is looking into bands in the Grand Rapids area.
- Cruz may have a campus visit lined up in the near future and will coordinate with the Baile if it is confirmed.
- Discussed the possibility of a visit to the Jim Crow Museum (Ferris). Would possibly include administration, student orgs, PCOD members.
- Cruz shared the Committee's motion with President Erickson. He verbally expressed support. Cruz will follow up on next steps. (Motion: The President's Committee on Diversity recommends adding a member to the Campus Master Planning Committee who is differently-abled and/or who has significant knowledge to ensure proper representation of those with special needs).
- Aim North students took EN 111 and NAS 101 during the summer. ODI will be following up in southwest Michigan (Dowagiac) and possibly northwest Wisconsin (Oneida).
