Your Free Application for Federal Student Aid (FAFSA) was selected for review in a process called "Verification." We will verify information from your FAFSA to ensure items were reported correctly. If there are differences between your FAFSA and the documents you submit to our office, we will make corrections. These corrections may result in an increase or decrease to your eligibility for financial aid programs.

Who is considered to be my parent? For purposes of this form, use the following guidelines:

- If your biological or adoptive parents *live together*, include information about *both* parents even if they are not now, or have never been, married to one another.
- If your parents are **divorced or separated**, report information for the parent you lived with most during the 12 months prior to filing your FAFSA. If this parent is remarried as of today, stepparent information must be included as well.
- If you live with a parent who was never married to your other parent and does not live with your other parent, or who is widowed and not remarried, include information for only the parent with whom you live.

If you submit additional documents with this form, please include the student's name and NMU IN (identification number) on each page.
