Northern Michigan University's Institutional Effectiveness (IE) office's main duties include institutional reporting, analytics, assessment, accreditation, and strategic planning. IE performs annual tasks, projects, and analyses utilized in decision support, reporting, and strategic planning. Ad Hoc inquiries and projects are also supported and range from simple to complex.
