Dr. Robert J. Wynn, Dean of the College of Arts and Sciences, spoke to us about how NMU has adapted to the virus. Twelve work groups (Technology, Safety and Health, Teaching and Learning, Engineering and Planning, etc.), led by Cindy Paavala and Mike Bath, worked together to make campus usable and safe for students, faculty, and staff.

Classes meet face-to-face, lecture/lab, online. Hybrid classes A meet mostly face-to-face, less online. Hybrid B meet mostly online.

Three styles of classrooms; some have stationary desks; others can be reconfigured. Now using 25%-60% normal capacity. Alternate meeting in person. Must take attendance every day so those can be identified in case someone tests positive.

Some students can't social distance – nurses learning to draw blood, cosmetology, students sharing equipment (Jacobetti), etc. They are given extra PPP, gowns, gloves, masks, face shields

Covid cases are staying in Spalding -Provided food, and other comforts as much as possible.

Quarantined- in contact with someone who tests positive

Isolated – Tests positive. Must stay in his/her room.

Many problems as each school/state/conference has different rules

May have to wait 2-4 days for test results it complicated to travel for events

E-games- new sport - computer games. NMU will evaluate games - non-violent - uses hand eve coordination – students can make 500 moves per minute

Sports on hold until January 1. Might play only each team once.

May test 50% of team every two weeks. Tests are \$120 each.

Family insurance first, then NMU secondary insurance, then NMU. NMU will pay for students don't have insurance (usually from rural areas).
