

# Northern Michigan University Retirees Association

Minutes of the August 11, 2016 Board Meeting

#### 1. Acceptance of VP candidate.

a. Tony Tollefson approached Sandi Poindexter prior to the start of the board meeting with an offer to fill an open AP board slot. As a first item of business, the Board accepted Tony. Very quickly it was evident that Tony had the skills and interest to serve as the VP and the Board appointed him to the open VP position. Bylaw Article I 1.4 permits the board action.

### 2. Programming discussion for F17.

- a. It was concluded that we should repeat the Chez Nous event with some modification for grouped seating; retain an athletic event utilizing exiting ticket benefits; and return to the prior format for the FRT event, i.e. inviting cast and director to a social meeting prior to the musical rather than hosting a reception at a performance.
- b. Attempting to have a monthly event would increase consistency and perhaps awareness of retiree events.
- c. Suggested NMU units/topics for presentation include Athletics, USOEC, NCAA selection or placement process, new sports, women's sports, conference v. non-conference games, meeting athletes, international programming and students.
- d. Participating in events with Alumni Association and NCLL (Northern Center for Life-Long Learning) could effectively increase activities without additional planning and/or costs.
  Sandi Poindexter is an NCLL board member and will work with its winter (Nov – March) curriculum planning committee to encourage a joint event.
- 3. **Recommended programming for F17**. M. Harmon will aid in communication to members, expenses, reservations and attendance recording.

However, it does require a vote of the board to do so. This will be handled with an email discussion.
