

# Northern Michigran Uliniversity Rettirees Association 

Minutes of the August 13, 2015 Annual Meeting<br>Location: Ontario Room, Don H. Bottum University Center<br>Start Time: $\quad$ 10:00 AM with refreshments and conversation<br>Number Present: 39 retired employees and spouses/guests

Opening remarks were made by President John Kiltinen at 10:20.

Vice President Yvonne Lee introduced the guest speakers from Northern Center for Lifelong Learning (NCLL), Sally Olson and Phyllis James. The history, offerings, costs and procedures were explained and handouts provided. It was also pointed out that NCLL is an NMU-affiliated organization, as is the NMU Retirees Association. However, NCLL membership is open to anyone in the community. It is not necessary to be a member of NCLL in order to attend its events/sessions, but the session cost is typically $\$ 3.00$ for members and $\$ 8.00$ for non-members. NCLL is open to holding jointly sponsored events.

Secretary Sandi Poindexter facilitated the business portion of the meeting covering the following topics: membership statistics, budget, retirees' survey results, bylaw change proposal, and Board elections. Handouts were provided for each. (See attached presentation slide handout for details on the survey results and bylaw change proposal.)

Retirees Survey Results

- The results were distributed to the NMU RA members through email and will be published on the NMU RA website. With an approximate response rate of $20 \%$, the results are considered reliable for use.
- Improved communications and additional venues for retiree events are survey concerns being addressed by the NMU RA Board in 2015. Members should watch for an email in September offering an opt-in choice for additional NMU email for activities, events and announcements.


## Bylaw Change Proposal

- Proposal was presented to change the current wording of Section 1.0. BUSINESS AND SOCIAL MEETINGS (Amended November 11, 2010) from 1.1 The general membership shall meet four (4) times a year. (Amended November 11, 2010) to 1.1 The general membership shall meet at least two (2) times a year.
- Concerns were expressed over an underfunded budget, the possibility the change could results as a defacto standard of two meetings a year, and a lack of evidence that alternative venues for events would increase attendance.
- A motion was made by John MacDevitt and seconded by Grant Soltwisch to amend the proposal to read "...shall meet at least three (3) times a year." The motion was defeated 10-11.
- Discussion followed on the original motion. The motion passed, 18-3, and the new bylaw for at least two meetings per year will be in force.

Board membership elections

- The slate of candidates was unanimously approved with the following Board members: Gerry Nault (2 yr AP slot); Elmer Moisio (2 yr Faculty slot); Sue Tollefson (2 yr TOP slot); Dan Hakala ( 2 yr Operations slot). A one-year Operations slot remains vacant.

Four jars of Soltwisch jam were given as door prizes. Dan Hakala won the 50/50 drawing.
The meeting was adjourned at 11:55.
A Board of Directors meeting was held immediately after the general membership meeting to plan activities for the 2015-2016 year.
