

MARQUETTE COUNTY COVID-19 TESTING SITES

Superior Walk-In Center 2382 US-41 Marquette (906) 226-2233
No appointment needed. Pull into parking lot and call. Registration and triage over the phone.
Will test symptomatic and asymptomatic people. Will bill insurance.

Walgreen's 1115 W. Washington St. Marquette (906) 226-1046
Go to [walgreens.com/findcare/covid19/testing](https://www.walgreens.com/findcare/covid19/testing). Scroll down and click on 'Get started' and follow the instructions. You will schedule your date/time then. No doctor order needed. Test is conducted at pharmacy drive-thru. Results in 2-5 days. Need to bring driver's license or state ID card. For now, test is free; paid for "by the state."

UPPER GREAT LAKES GWINN FAMILY HEALTH CENTER

Testing is available at their Sawyer and Houghton locations.
Call (906) 346-9275 at 8 a.m. to schedule a testing appointment for the same day. (No advance scheduling is available.)
They bill insurance but have funding on a sliding scale for uninsured/underinsured.

Monday-Friday, 8 a.m. – 5 p.m. By appointment only.
Call 485-2749 to make a testing appointment. Asymptomatic people may be bumped for symptomatic.
They bill insurance.

SINGLE TRACK HEALTH 107 Main St. Suite #2 (906) 662-4070
Drive-up testing (weekdays) daily: Mon-Thurs starting at 5 p.m., Friday starting at 3 p.m. By appointment only. Go to singletrackhealth.com to fill out forms and choose a testing day (can only be within the next 3 days). There is a cut off time for same-day testing: Mon-Thurs by 3 p.m., Friday by 1 p.m.
\$40 copay with and without insurance (They DO bill insurance if patient has it.)

UPHS-Marquette Old Hospital ER on W College Ave (906) 449-1660
Call direct to request/schedule test. Tests are prioritized (healthcare workers first, etc.). The test is drive-through and by appointment only.

Peninsula Pharmacy Plus 300 N McClellan Ave. (906) 225-1450
By appointment only. Monday – Friday at 12:30 p.m. Call ahead for appointment and to pay over the phone. Cost is \$90. They do NOT bill insurance. Results are same day – usually within the hour.

**Turn around time for results can vary. Call facility for most up-to-date results times.
