Purpose

- 1. Curriculum Development Grants are intended to support efforts at the departmental or interdepartmental level and focus on modifications, advancements or improvements in the curriculum. Proposals must clearly demonstrate how the proposed work exceeds those curriculum development activities normally expected from an academic unit to adequately justify additional funding.
- **2. Instructional Improvement Grants** are intended to support projects that offer one or more faculty members the opportunity to improve their instructional skills, implement new teaching methodologies, or develop innovative materials. Course development for international courses are included in this category.

Requirements:

Curriculum development proposals require:

- Departmental Statement: This statement should be prepared and signed by the departmental curriculum committee. It should contain a statement of how the proposed project would relate to the mission of the department.
- Approvals: If release time is requested to be absorbed by the department, the application must include a letter of approval signed by both the department head and appropriate dean.

Instructional Improvement proposals require:
