A. President -Zora

D. Members with Discussions

1. Elections Committee - Anna Tousley

a. Anna: "Hello everyone! I have a little bit of information that I feel is important for everyone to know in an effort of transparency. Before I get into the nitty-gritty, I want to make three things very clear: I wrote this speech before the election results were in, I asked this to be put on the agenda before the election results were in, and Jim and I talked about this before the election results were in and we felt this was the best way to bring this up. So please do not think I am talking about this because I am a sore loser. As some of you may know VP and Presidential debates were recently held, in my debate my opponent not once but twice commented on my grade level as a way to put me down and make me seem lesser than those around me. This is not a target towards Micah, please be aware of that, that was his prerogative and while I think it was unnecessary, I am only mentioning this as a backstory. Kylie was the one who asked if I wanted the Director of Ex Aff position & amp; encouraged me to apply for speaker of the assembly, so I find the next part very disappointing. Last week, I was informed that Kylie, a current member of e board and an elections committee member, was talking about

it publicly and agreed with Micah's comments. Her position on the elections committee should and does prevent her from talking about opinions about candidates. As some of you may know, I had an election complaint filed against me, During my elections complaint meeting (regarding me talking about people behind their back), she grilled me on being professional, being nice to others, and all that sort of stuff--it is not okay for her to be in the position to grill me when she has done the same thing to me behind my back. When I brought this up with Olivia, she said she talked to Kylie about " bias and professionalism" but made it seem like the only thing stemming from that conversation was just being talked to. As a result of my meeting, I sent an apology to that person. But I never received an apology or acknowledgment of wrongdoing from Kylie. Moreover, at the Gender Fair last Friday, I saw a person who was helping run the debates but was not introduced that night. When I saw her at the fair, I asked her who she was and that I didn't mean to come off as offensive, just that I didn't know who she was and she obviously knew who I was. It was Julia, another member of the elections committee; I learned to be Kylie's roommate. After this encounter, she was telling people, I don't know specifically who, that I was rude to her at the fair & that she thought asking her who she was, was rude. I believe this to be subjective, and considering her position on the committee, she should have kept those comments and opinions to herself. She brought this up to me in my elections complaint meeting, but that should have been the only appropriate time to discuss any perceived rudeness on my part (in my humble opinion, I was not being rude, it just caught her off guard.) Again, I got grilled by her for professionalism and being an example. Again, she knowingly spoke to me and reprimanded me while having done the same thing to me in the past week. I am accepting responsibility and accountability

for my mistake and I want them to have the same. While it is too late to file any formal elections complaint, I chose not to as it would've resulted in their removal, and while I may be a little petty, I am not that petty. As much as everyone loves unwarranted advice, I'll give some: rules, duties, and responsibilities are meant to be followed by everyone. I find it hypocritical and unfair to have certain members held accountable, but members of our current e board and elections committee face no sort of accountability. That is not good, exemplary leadership and it shouldn't be portrayed as such. So as you walk through life, I want to remind everyone that what comes around goes around and that you are not better than someone else because of your title. You are not better than someone else because you are on one side of the table and they are on the other. This is why people have such issues with politics and politicians and why the turnover rate in ASNMU is so high. If you expect people to want to continue in this organization, I highly recommend not speaking down on others in this fashion. What has happened, happened. But I am mentioning this for transparency and as a failure on the elections committee's part. Your grade level, or any factor you otherwise cannot control, does not determine your abilities, status, or character, and it is not written anywhere in our guiding documents that grade level is such a factor. The elections committee should've been aware of that. As new members are in the room, I want to encourage all of you to be better than this in the next election cycle and year. It is not okay for elections committee members to speak any opinions, good or bad, about candidates as it can sway votes and I want to encourage all of you that if you see something or know something, say something. As you work to form the next elections committee, seek to find members who are honest and will not treat members in this same fashion. Thank you."

b. Kylie: "I would like to apologize that I did

not reach out to you and did not feel it was necessary. It was not something that was told to me. However, I really wish you brought it to me, before bringing it to the elections committee and to GA, because that did not happen. The only two people I told were my roommate and a former elections committee member. As well as for making comments on the debate, I encouraged people to watch the debate and to get their information and learn about their candidates, which is in direct alignment with my job and the elections committee. I do wish you would have spoken to me because this is the first time you have said anything to me and I respectfully disagree with it."

- c. Zora: "I will say the drama with this election cycle was unnecessary and unprofessional, and I think that everyone in this assembly should be better than that drama. We are not here to start drama or engage with it, we are here to advocate for students and that's what we should be doing and if we can't do that and work together to achieve that then our whole organization falls apart and then there'd be no shared governments with students. It was really disappointing to me to hear about the drama that was going on, because we are held to such a high standard, not just by other students but also with the faculty and administration. If we can't act like professionals then we aren't taken seriously and there's no point in meeting with anybody."
- d. Anna: "I was told about that comment from someone else, and it is possible it was taken out of context, but I do know where the comments were made and what context those comments were made. I brought it up with the assembly as advised by Jim."
- e. Kylie: "I have no issue bridging it to the assembly, I do wish you would've brought it to me and discussed things with me."
- f. Gwen: "I do think it is also fair for me to say something in addition. It's quick to run and defend ourselves. I'm sorry, I'm sorry

that happened. I saw it and it made me angry. I am sorry this assembly in a sense failed you. That's not me blaming anybody or saying someone is right or wrong, but at the end of the day that is how that made you feel then that's how it made you feel. That happened, and I felt it too, and I am still feeling it and it sucks and I am really sorry. Moving forward, I think so much on communication and no more behind closed doors talks. You're allowed to talk to who you want but things that happened behind closed doors do not come out that way that they were said. Things get muddled, things get mixed. We ask the administration to be transparent all the time, we ask for honesty, and I don't think that it's fair we aren't being held to the same standards. It's not fair that people are hearing muddlings from everybody behind everyone's back and going forward, personally I am not going to stand for it. Personally, I appreciate you, Anna."
